

ITEM ONE: Report

Concerning the arrest of Regame Konstantin Rudolfovich, b. 1879, a Pole, Soviet cit[izen], n/P [non-Party member], professor of music, residing at 14/2 Tarasivskiy St.

Regame presents himself as a client of the Polish consulate in Kyiv. His visits to the consulate were long. Regame's son, with whom he maintains contacts, lives in Poland. According to our spy network, Regame's flat is visited by suspects from other Soviet cities.

Regame is suspected of espionage. We believe he must be arrested.

ITEM TWO: From the minutes of the interrogation

Reply: That's right, I have indeed been an informer of the Polish consulate in Kyiv since 1934.

Question: What were the circumstances of your recruitment and how were orders concerning your activity as a spy passed on to you by the Polish consulate.

Reply: Early in 1934, the Polish consul invited me by mail letter to come to the Polish consulate.

When I came to the Polish consulate, the consul read me a letter from Dobrowolska, my sister, who wanted to know how my health was.

The consul said he knew my sister very well, that he frequently visited her at home and that she asked him to pass her letter on to me.

The consul began to question me about my life in the Soviet Union, whether I suffered hunger. He also wanted to know where I work.
